North American Shetland Sheepbreeders Association (NASSA) membership is open to anyone interested in the breed. NASSA membership benefits include: 1. Recognition by British registries, as NASSA was founded in 1991, and adopted the 1927 Shetland Breed Standard of the Shetland Flock Book Society. 2. A copy of the Shetland Handbook, a good source of information about Shetlands, available online to members. 3. The ability for flock owners to record Registrations and Transfers of purebred Shetland Sheep in North America. 4. A registration certificate and four-generation computer generated pedigree for each sheep registered. 5. *NASSA News*, a quarterly newsletter providing news and information about Shetlands. 6. Eligibility to obtain an account for the online NASSA Database "Members only" site.

Active membership and flock registration are required to register or transfer Shetland ownership, hold office, or vote in a NASSA election. Members are also able to renew membership, register and transfer animals online at the NASSA web site. New members registering a flock must choose a unique Flock Prefix with 12 characters maximum. It is recommended that you submit an alternate choice in case your first choice is already in use.

• Junior Member- Non-voting membership, one newsletter per household. Only a Regular or Junior member may register or transfer sheep. Initial Membership, \$25 US. Includes flock registration fee. Annual renewal, \$15 US, Must be upgraded to a Regular membership upon reaching the age of 18. Note: Anyone under the age of 18 **MUST** register as a Junior Member.

• Associate Member - Newsletter only, no voting privileges. Initial Membership, \$30 US. Annual renewal, \$25 US. *May be upgraded to a Regular membership by paying a flock registration fee of \$10 US and acquiring sheep.*

• Regular Member - Must own Shetland sheep. Only a Regular or Junior member may register or transfer sheep. Initial Membership, \$40 US. Includes flock registration fee, newsletter, and voting privileges. Annual renewal, \$25 US. *Note: All fees must be paid in US Dollars. Anyone presenting a check that is rejected by the bank will be responsible for all bank fees
